WHEREAS, the Housing Authority desires to continue to promote the development of additional affordable rental housing for the City of Avon Park to reduce existing need as represented in the Authority's extensive Wait List of applicants to its affordable rental housing inventory, and

WHEREAS, the Housing Authority's affiliate, Avon Park Housing Development Corporation, has elected to pursue additional State HOME funding available for the development of affordable rental housing in the City of Avon Park for a project titled Cornell Colony, and

WHEREAS, the award of such funding will provide for the addition of 44 newly constructed single family affordable rental homes on a single site location in close proximity to the APHA's property management operations, and

WHEREAS, the Housing Authority would benefit financially through achieving economies in scale cost savings by serving as the Property Manager for such development, thereby increasing the positive cost benefit impact for APHDC, APHA and the Avon Park community at large.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF THE HOUSING AUTHORITY OF AVON PARK, FLORIDA:

SECTION 1. The Authority hereby endorses and advocates the decision and efforts generated by the Avon Park Housing Development Corporation in the pursuit of such new affordable housing development and,

SECTION 2. The Authority hereby extends and offers its Property Management expertise to APHDC for Property Management service consideration in conjunction with operational oversight for proposed Cornell Colony development.
